- 5. Sealed bids must be submitted to Sunil Smriti Rural Municipality Office of Rural Municipal Executive Sulichur, Rolpa by hand/courier before 04 May 2019 12:00 hrs. Bids received after this deadline will be rejected.
- Sealed bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security amounts to a minimum of NRs 1,20,000/- (One Lakhs Twenty Thousand) only per bid document, which shall be valid for 30 days beyond the validity period of the bid (i.e. not less than 120 days after last date of bid submission).
- 7. Sealed bids shall be opened in the presence of Bidders' representatives who choose to attend on 04 May 2019 14:00 hrs at Sunil Smriti Rural Municipality Office of Rural Municipal Executive Sulichur, Rolpa.
