The Bid will be opened in the presence of Bidder's representative who choose to attend at at 13:00 hrs. 08 Oct. 2021 for NCB and at 13:00 hrs ,23 Sep. 2021 for sealed quotation at the office of Sunil Smriti Rural Municipality Sulichaur, Rolpa. Bids must be valid for a period of 90 days for NCB and 45 days for sealed quotation after bid opening date and must be accompanied by a bid security or scanned copy of the bid security in PDF format, amounting to a minimum of as specified below which shall be valid for 30 days beyond the validity period of the bid after deadline for last date of Bid submission.

6. If the last date of purchasing and /or submission day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
